Executive Summary

The year 2021 had been a year of economic recovery across the world including in Africa where the Covid-19 pandemic has been particularly damaging for the supply chain and reversed over two decades of economic gains on the continent. Increased cooperation between governments and the private sector had been witnessed. The U.S.-Africa Business Center has continued to serve as the leading advocacy organization focused on the policy and regulatory environment that is shaping Africa's commercial links with the world.

In 2021, the USAfBC issued a series of key Policy recommendations for the New U.S. Administration, resounding that the future of the U.S. export-driven economy lies in Africa. After a series of engagements with key officials and conversations with NSC and government leadership, the administration announced President Biden's intention to host a U.S.-Africa Leaders' Summit in 2022, which was the Center's #1 recommendation.

The Center advanced new bodies of work in corporate citizenship, as we launched and published an in-depth study on U.S.-Kenya Trade Negotiations: Implications for the Future of the U.S.-Africa

Trade Relationship. We also partnered with Covington to launch the Status Update on AfCFTA, of which two editions have been produced. These were created in consultation with the AfCFTA Secretariat, which members met with in December, where the second edition of the newsletter was presented to H.E. Wamkele Mene and the AU delegation.

The Center also worked on a number of regional policy issues, including the launch of the **Angola** and **U.S.-Burkina Faso Investment Guides** respectively, and in October 2021 the latter was introduced in a hybrid event by H.E. President Kabore of Burkina Faso as well as both the US and Burkina Faso ambassadors. As part of our continued commitment to U.S.-Angola relations, we also launched the Washington DC based **U.S.-Angola Working Group** as part of a long-term effort to support business investment opportunities in the Angolan market.

Under the U.S.-South Africa Business Council, the Chamber provided the South African government with comments on the amendment of regulations to the Promotion of Access to Information Act (POPIA) regarding the protection of South African citizens' personal data. The council hosted events to keep members abreast with happenings in the South African Market

Through our Task forces, we facilitated dialogues on the digital economy, trade, investment, and life sciences & wellness. Through the industry coalitions we convened, we raised and resolved policy and regulatory issues, delivering a substantial return on investment to our members and policy wins on a wide range of matters, including through shaping the Prosper Africa initiative.

With these milestones as a backdrop, the USAfBC continued to expand its impact on U.S.-Africa relations. We hosted 5 heads of state, 13 ministers, and 16 Ambassadors. We convened major events including the **Advance with Africa AmCham Summit,** two CEMAC regulation Stakeholder Conferences in collaboration with CCA, the U.S.-Ghana Business

Forum, the Virtual Private Sector AGOA

Forum and our annual flagship event, the 2022 Africa Digital Economy Summit.

In 2022, the center will focus on areas of excellence in the policy space by doubling down on its leadership role in the trade, investment, digital economy, sustainability, life sciences and wellness areas. We will continue to build out the U.S.-Angola Working Group, celebrate the 10th anniversary of the U.S.-South Africa Business Council and have a keen eye toward Algeria, Angola, Ethiopia, Ghana, Kenya, Morocco, Nigeria, Senegal, and South Africa.

2021 Spotlights

UNGA 2021

In September 2021, the USAfBC hosted a number of high-level events featuring African Heads of State on the margins of the U.N. General Assembly Meetings in New York City. On September 20th, we were pleased to host USAfBC members as we welcomed the President of Angola, João Manuel Gonçalves Lourenço, the new Minister of Planning and Economy Mario Augusto Caetano João, and other key Ministers for this crucial discussion on the objectives and outcomes of the Center's U.S.-Angola Working Group, as well as more generally of the opportunities to strengthen economic relations between our two countries. The event featured remarks by Ambassador Nina Fite, as well as Clav Neff from Chevron and Robert Berman from Sun Africa as we presented updates on the US Chamber's U.S.-Angola Working Group and emphasized the enduring partnership between our two nations. We were also honored to host a historic MOU signing between Chamber member Sun Africa and the Angolan Ministry of Energy and Water, for which we were joined by Acting Under Secretary of Commerce for International Trade Diane Farrell, DAS for Middle East and Africa Camille Richardson and DAS for Department of Energy, Maria DiGiulian.

On September 23rd, our U.S. Chamber team met with Zambian President Hichilema during his visit to Washington. Hichilema was accompanied in the meeting by Finance

Minister Situmbeko Musokotwane, Foreign Minister Stanley Kakubo, Ambassador Lazarous Kapambwe with and a handful of advisors. The visit did afford us the opportunity to raise the priorities members shared with us. Ambassador Kapambwe delivered a message indicating the President's interest to work with us on trade and investment priorities: both the Ambassador and Finance Minister offered to work with us on the issues raised.

Virtual Private Sector AGOA Forum

On October 19, 2021, the U.S. Chamber of Commerce's U.S.-Africa Business Center convened a virtual private sector AGOA Forum on the Digital economy to complement the AGOA Trade Ministerial hosted by the Office of the U.S. Trade Representative. Several hundred experts from the business community, diplomatic corps, U.S. and African governments, and international organizations joined the Chamber-organized forum under the theme of "Leveraging New Pathways to Trade: Enabling the Digital Economy" in recognition of the accelerated pace of digital transformation occurring globally and the opportunity it presents for African economic growth. The forum focused on two aspects of the digital economy - the ecommerce sector and creative economy that have demonstrated the potential for African economies to increase their GDP when African access global supply chains, generate employment within the sector as well as related industries that support the

digital economy, and spur innovation. ensure that future African trade with the United States can continue to build on AGOA's first generation success in promoting economic opportunity and jobs creation in Africa and the U.S., its future needs to be based in the digital economy and supported by sound policies that enable its expansion.

Participants underscored the growth potential for the sector and its capacity to expand the number of enterprises involved in global trade and their opportunity to reach new markets. Keynote speakers provided case studies and panelists articulated the importance of creating the right enabling environment for African countries to be able to leverage the opportunity for expanding cross-border trade both within the continent and with the United States. Presenters spoke to some of the necessary ingredients in an ecommerce ecosystem for the sector to drive trade within the context of AGOA as well as the African Continental Free Trade Area (AfCFTA) that has initiated trading and will soon take up ecommerce in its forthcoming round of negotiations. During a Fireside Chat with Kenya's Cabinet Secretary for Industrialization, Trade and Enterprise Development, the Forum examined the success story of Kenya, which has one of the highest rates of utilization of AGOA, and the incentives it provides as part of a holistic strategic partnership with the United States.

Panelists and keynote speakers alike addressed the tremendous opportunity for the creative and cultural industries to drive growth on the continent, support employment opportunities and skills development that further fuels the sector across Africa. Distinguished speakers and panelist made the case for the ways in which U.S.-African partnership can create a virtuous circle of growth in a sector that is rapidly expanding.

To kick off the Center's digitally focused program series, the U.S.-Africa Business Center hosted a cocktail reception on December 1, to celebrate the economic partnership between the United States and Africa and to honoring the achievements in the digital economy by business, government, and international organizations that are driving innovation and spurring growth for Africa and the U.S.-Africa trade and investment relationship. We were honored to have in attendance members of the African Diplomatic Corps, high level government representatives, partners, and corporate executives.



The event featured remarks from the Ms. Dana Banks, Special Assistant to the President and Senior Director for Africa, National Security Council and the Honorable Amb. Carlos dos Santos, Ambassador of Mozambique Co-chair of the Economic Development Committee of the African Diplomatic Corps. Amb. Karan Bhatia, Vice President, Government Affairs and Public Policy for Google, delivered a keynote address as our event sponsor during a program hosted by U.S.-Africa Business Center President, Scott Eisner.

On December 7, more than 700 executives tuned in to the 2021 Africa Digital Economy Summit. Following a welcome from Scott Eisner and an opening address from Myron Brilliant, Executive Vice President and Head of International Affairs for the U.S. Chamber of Commerce, we were pleased to feature the keynote address from the President of Zambia. H.E. Hakainde Hichilema. Audience members also heard from Nitin Gajria, Managing Director, Sub-Saharan Africa, who talked about the company's partnership with the continent via its Google for Africa initiative launched in October. Amb. Vinai Thummalapally, Acting Director of the U.S. Trade and Development Agency, talked about the work of the U.S. government to support infrastructure development on the continent to power Africa' digital transformation. In his remarks, Amb. Thummalapally told the audience that working with African partners to support digital transformation is one of the top priorities globally for the U.S. government agency.





The event featured a dialogue on the growth of digital finance companies, and the opportunities for fintech to be a driver of inclusive growth on the continent. The forum was pleased to feature executive women from the Better than Cash Alliance (UN initiative) and Flutterwave.

The Center through the Executive Director, Dr. Guevera Yao, announced the 2022 African Digital Startup Competition series, which has been developed and is being launched in collaboration with the American Chambers of Commerce. The competition will kick off in Q1 and will culminate with the award of regional and Africa Digital Startup Champions during our flagship Digital Africa Summit in December.

This event was sponsored by Google (Digital Driver), Flutterwave (Digital Innovator), Vista Bank (Digital Champion) and Citi (Digital Architect).













Angola Working Group Launch

On June 9, 2021, the U.S. Chamber of Commerce launched a new U.S.-Angola Working Group, a collaboration between the Chamber's U.S.-Africa Business Center and AmCham Angola. The U.S.-Angola Working Group – the product of multiple years of effort by the Chamber and its partners – is a private sector-led platform to advance the business community's priorities for U.S.-Angola engagement. Its formation reflects the positive trajectory of Angola's economic reforms, as well as growing corporate interest in the country. Reforms, such as the Private Investment Law, the Investors' Visa, Antitrust Law, and other economic policies, are all indicative of country ready to restore investor confidence and sustaining economic growth.

In September 2018, on the margins of the U.N. General Assembly in New York, the U.S. Chamber hosted President João Lourenço, where he presented his new vision for Angola, referred to as the "New Angola", and his resolve to combat corruption, diversify the economy, and create a more business-friendly environment for private sector investments. In December 2020, President Lourenço attended a business roundtable of the U.S. President's Advisory Council on business in Africa (PAC-DBIA) and announced the launch of the country's privatization plan with nearly 200 public companies, and other potential investment opportunities available for the U.S. business community.

Although Angola, like many oil-producing countries, has been grappling with the dual effect of the COVID-19 pandemic and the falling oil price, the government has been resilient and persistent in its drive to pursue the needed reforms to attract foreign direct investments. To build on these multi-year efforts, and the sustained engagement of the U.S. Chamber into the Angolan market, the

USAfBC launched its D.C.-based U.S.-Angola Working Group to serve as a private sector-led platform to advance the business community's priorities for U.S.-Angola trade and investment relations. The launch of the Working Group featured the U.S. Ambassador to Angola (Amb. Nina Fite), and the Ambassador of Angola to the U.S. (Amb. Joaquim do Espírito Santo), who both share their perspective on the state of the U.S.-Angola economic relationship.

The Working Group, chaired by Chevron with John Deere as Vice Chair, is a private sector-driven initiative for policy advocacy, convening, and connecting as well as business insights on key opportunities in the Angolan market. It is composed of 5 technical sub-committees that meet on a regular basis to discuss issues of common interest and will build a coalition on key priority sectors such as (i) agriculture & Sustainability (led by John Deere), (ii) infrastructure & energy (led by Chevron), (iii) banking & financial services (TBD), (iv) digital economy (led by IBM); and (v) health and wellness (led by GE Health).

In September 2021, the Working Group published a technical report to outline the opportunities, challenges, and recommendations to improve the ease of doing business in key sectors of activities in order to strengthen the U.S.-Angola commercial relationship. The report was presented to both Angola and U.S. government officials at the U.S. - Angola Executive Business Roundtable, featuring H.E. President João Lourenço and a ministerial delegation.

US-SABC Council

The U.S.-South Africa Business Council (US-SABC) serves as the premier Washington-based organization dedicated to strengthening the economic relationship between the U.S. and South Africa. The council, composed of senior-level executives from U.S. and South African companies, represents the leading investors doing business in every sector with South Africa and within the Southern African region. The US-SABC's goals are three tiered: enrich investment and trade between the U.S. and South Africa, serve as a platform for commercial engagement at the most senior levels of business and government, and enhance investment in the Southern African region by U.S. and South African companies.

The US-SABC regularly weighed in on the trade, investment, and regulatory issues facing U.S. and South African companies thereby highlighting the impact and importance of the U.S.-South African bilateral relationship for influential government stakeholders. The council also served as a respected industry voice, translating member feedback into real policy changes. The council focused on the following issue priorities: Digital Economy, Workforce Development, Intellectual Property and Data Flow, Infrastructure, Energy Development, Labor Market Reforms and Broad-Based Black Economic Empowerment (BBBEE), Banking and Finance, Retail and Supply Chain, and health systems.

The Council welcomed Nyimpini Mabunda, Chief Executive Officer of Southern Africa for General Electric (GE), as its new Board Chair. He is joined by Zwelethu Bashman, Managing Director for South Africa and Sub-Saharan Africa of MSD, who serves as Vice-Chair. Mabunda and Bashman assumed their leadership roles during the first US-SABC board meeting of 2021.

Under their leadership, the Council convened various signature events, including hosting U.S. Investment Roundtable on Doing Business in different provinces- a dialogue with the Premier of Western Cape, Alan Winde, Premier of Eastern Cape, Oscar Mabuyane, and the Premier of Limpopo Province, Chupu Stanley Mathabatha.

The Council also held conversations with top U.S and South Africa government officials featuring Minister of Trade Ebrahim Patel during the Advance with Africa AmCham Summit, Amb. Todd Haskell, Charge d'Affaires, U.S. Mission to South Africa, Dr. Gail Andrews Health Attaché, Embassy of South Africa, Dr. David Masondo, Deputy Finance Minister and Deputy Assistant Secretary of State, Akuna Cook.

In 2022, the Council will be marking its 10th year in existence with programming showcasing the impact of her work within the past decade.

Task Force Updates

Digital Economy

This year the Digital Economy Task Force proactively leveraged high-level events to drive policy advocacy on cross-border data flows, data localization, data protection, cybersecurity, connectivity, FinTech, and blockchain technology.

As part of our programming for 2021, the taskforce convened a virtual private sector AGOA Forum on the Digital economy where several hundred experts from the business community, diplomatic corps, U.S. and African governments, and international organizations joined the Chamber-organized forum. The forum focused on two aspects of the digital economy - the ecommerce sector and creative economy.

The month of December was themed a digital month as it featured series of digital focused events, opening with the 2021 Africa Digital Reception celebrating the economic partnership between the United States and Africa, honoring the achievements in the digital economy by business, government, and international organizations that are driving innovation. This event was followed by the Center's annual flagship Africa Digital Economy Summit 2021, that featured a dialogue on the growth of digital finance companies, and the opportunities for fintech to be a driver of inclusive growth on the continent and Keynote remarks from the President of Zambia, H.E. Hakainde Hichilema. Finally, a Digital Africa Roundtable with USG, was convened in a Private Consultation of USAfBC members with the U.S. government to learn more about the Digital Africa initiative being developed by USG to be a signature program of this Administration.

Trade

The U.S. – Africa Business Center's Trade Task Force (USAfBC-TTF) was launched in 2020 and leveraged on the previous Retail, Supply Chain & Trade Facilitation Task Force. The USAfBC-TTF served as a consultative and exchange platform for U.S. Chamber's member companies to engage with policymakers on U.S. - Africa trade matters. The task force focused on bilateral and multilateral trade by addressing regulatory and policy advocacy issues to expand trade between the U.S. and Africa. New U.S. Government trade and investment initiatives (e.g. Prosper Africa), as well as growing interest in increased two-way trade with Africa (e.g. U.S.-Kenya Free Trade Agreement announcement), are also discussed. In addition, the task force discussed the future of the existing preferential trade mechanism - the African Growth and Opportunity Act (AGOA) – set to expire in 2025.

Following the announcement by the African Union ("AU") that trade in goods under African Continental Free Trade Area ("AfCFTA") will commence from January 1, 2021, Task Force calls were held by the Center with the AfCFTA Secretariat to provide an opportunity for members of the task force to better understand the implementation process of the agreement and its implication on the U.S. private sector. On December 16, the USAfBC and the CCA hosted a roundtable discussion featuring H.E. Secretary General Wamkele Mene, who discussed the lessons learned from the first year of trading under the AfCFTA, the next steps in the AfCFTA negotiations, and opportunities for the U.S. business community to engage in the future of trade throughout the African continent.

As part of the activities of the task force, a quarterly newsletter was launched in August 2021, in collaboration with Covington Burling, to provide members companies with the

status updates on the negotiations and implementation of the AfCFTA agreement. In December 2021, the second issue of the AfCFTA Newsletter was published to take stock of the progress made on the continental trade under the preferential terms of the AfCFTA.

Life Sciences & Wellness

The Life Sciences & Wellness task force focuses on how countries can improve their health sector, specifically through increased U.S. investment in lifesaving medicines, medical devices, and pharmaceuticals markets. This year the task force kept members up to speed on regulatory changes affecting pharmaceutical and medical device companies in the task force's priority markets: Algeria, Kenya, Morocco, Nigeria, and South Africa.

In the fall, the task force hosted a roundtable with Dr. Gail Andrew, the South Africa health Attaché, to discuss health priorities in the South Africa space. Earlier in the year, the task force in partnership with the US-SABC hosted a webinar on the Manufacturing Capability & Investment Opportunities in the health care sector in South Africa.

Investment

In April 2020, the U.S. Chamber of Commerce's U.S.-Africa Business Center (USAfBC) launched an Investment Task Force focused on U.S.-Africa investment trends and policy priorities that enable a favorable investment environment across the African continent as well as increased capital flows between markets. The task force served as a platform to discuss creative financing opportunities and assist members with the mitigation of perceived challenges impeding trade and investment, as well as deal flow. Through this task force, the U.S. Chamber

pursues partnerships with the U.S., African governments, and multilateral institutions. The task force further aims to strategically expose USAfBC members to policy issues that will drive their investments in a multitude of sectors around the continent as well as new and creative financing opportunities.

On March 15, 2021, the U.S. Chamber's U.S.-Africa Business Center hosted the World Bank's Chief Economist for Africa, Dr. Albert Zeufack, as a guest speaker to share the Bank's perspectives on Africa's economic outlook and its priorities in support of the continent's economic recovery.

The World Bank Group has been at the forefront of the global relief efforts, as one of the frontline multilateral institutions in charge of mobilizing financial resources and technical assistance for developing economies, including African countries. On August 31, 2021, the IMF's Regional Studies Division Chief for African Department, Mr. Papa Diop, was hosted to an update on the IMF's efforts to support the continent's economic recovery with a focus the Special Drawing Rights (SDRs) approved by its board.
